General:

The contractor shall provide all terrain vehicles (ATV's) and utility vehicles (UTV's) on an as needed, if needed basis as ordered by the state agency. The contractor must comply with all mandatory requirements and specifications presented herein pertaining to provisions of ATV's and UTV's.

Latest Model Requirement:

The contractor must provide current production year utility and/or all terrain vehicles with all manufacturers' standard equipment and additional equipment required by the State of Missouri.

All items of standard equipment which are normally provided by the manufacturer shall be furnished and factory installed unless such items are expressly deleted by the state agency or are specified to be other than standard.

At the time of delivery, each utility and/or all terrain vehicles shall be clean, lubricated, serviced, and ready for immediate use.

Warranty:

The contractor must provide the manufacturer's standard warranty for parts and labor on all utility and/or all terrain vehicles provided for a period of at least twelve (12) months. The contractor must provide a properly executed warranty with delivery of each vehicle. The warranty shall not become effective until the utility and/or all terrain vehicles are placed in service. The State of Missouri will formally notify the contractor of the "in-service" date for each utility and/or all terrain vehicle.

Title and Certificate of Origin:

The contractor must provide the title and certificate of origin for the utility and/or all terrain vehicle upon delivery to the state agency. Certificate and title application must be made as stated by the state agency purchasing the unit for each vehicle purchased by the state agency.

Delivery Performance:

The contractor shall deliver the utility and/or all terrain vehicles in accordance with the contracted delivery times stated herein to the state agency upon receipt of an authorized purchase order. All deliveries must be coordinated with the state agency.

The contractor shall deliver the utility and/or all terrain vehicles to various state agency locations throughout the State of Missouri.

With regard to any utility and/or all terrain vehicle delivered under the contract, the contractor shall comply with the manufacturer's recommended pre-delivery service.

Substitutions:

The contractor shall not substitute any item(s) that has been awarded to the contractor without the prior written approval of the Division of Purchasing and Materials Management. Any product substitution must be of equal or better functionality and of equal or lower pricing.

The state reserves the right to allow the contractor to substitute any new product/system offered by the contractor on all unshipped and future orders if capabilities and quality are equal to or greater than the product/system under contract and

if prices are equal to or less than contract prices. The Division of Purchasing and Materials Management shall be the final authority as to acceptability.

Replacement of Damaged Product:

The contractor shall be responsible for replacing any item received in damaged condition at no cost to the State of Missouri. This includes all shipping costs for returning non-functional items to the contractor for replacement.
