Two contracts have been awarded to serve state agency needs for various types of tires. The following Tire Groups are on the contracts:

Tire Group One: Passenger, Radial Ply, Steel belts, S ply rating, standard load, tubeless

Tire Group Two: Light Truck, Bias nylon/polyester, black tubeless or tube type

Tire Group Three: Light Truck, radial, black tubeless or tube type

Tire Group Four: Medium Truck, radial, ply

Tire Group Five: Off-Road Bias, tube type, nylon 100 level or better

Tire Group Six: Front and Rear Agriculture & Industrial, OE Equipment or Equal

Tire Group Seven: Certified High Speed, radial tube, tubeless - Law Enforcement Vehicle Use

Tire Group Eight: Retreads

Tire Group Nine: Miscellaneous, i.e., all tire types not previously identified in Groups 1-8

Some tires are specifically identified and priced. Tires not specifically identified and priced are available at the contractor's current list price minus the applicable discount quoted for the specific Tire Group. The following charts identify specifically priced tires by Group as well as the Tire Group Discount.

State agencies receive the discount on the lowest price for the tire published in the contractor's price listing. Bridgestone prices off the "Confidential Government Price Catalog" effective January 1, 2008. Catalog pricing may also be available via the Bridgestone web-site at www.bfntgovtires.com.

Goodyear Tire & Rubber Company tires are listed in the "G302 Federal Open Market & New State Price Book" dated 3/1/08 with the exception of Tire Group Eight (Retreads) which are priced from Goodyear's "B252/B253" catalog dated 7/1/08. Catalog pricing may also be available via the Goodyear web-site at www.goodyear.com/gov.

Delivery:

The contract allows for agencies to order and pick-up tires at dealerships participating in the contract. Tires may also be shipped to the state agency site FOB Destination, freight prepaid and allowed.

- Bridgestone offers fifteen (15) days ARO.
- Goodyear offers thirty (30) days ARO

Tire services are also available on each contract. Contract line items 069-077 represent the variety of services available at fixed prices.

The following chart lists both the Tire Group Discount as well as the firm fixed price for the specifically identified tire. State agencies receive the quoted price per tire as shown for the specifically identified tire for the duration of the contract period. Other tires within a Tire Group can be purchased under the contract at the contractor's current catalog price minus the fixed discount shown for the Tire Group. Tire pricing derived from the catalog may vary during the contract period although the discount remains fixed.

Missouri Tire Dealers:

Attachment One lists Goodyear dealers in Missouri and Attachment Two lists Bridgestone dealers in Missouri. These are attachments that are separate from this Statewide Notice but they are available at the same website.

Invoicing and Payments

All orders will be placed with the manufacturer in care of the local dealer providing services. Invoices will be billed by the manufacturer and payments will be made to the manufacturer, not the local dealer.

Preferred Use Contract:

The State of Missouri has various state agencies that are located in remote areas of the state with limited access to a nearby dealer. Because of the time it takes state personnel to travel along with the cost associated with travel to the closest authorized tire dealers, the state intends to provide as much variability as is needed to obtain the tires and service. The State of Missouri must also be assured the product is readily available.

For the reasoning cited in the above paragraph, the contract shall be considered a preferred-use contract which means all state agencies should use the contract for the supplies and service on contract if needed. Even though the contract is considered a preferred-use contract, there will be rare situations where an agency may waive itself from using the contract so long as such determination is supportable and in the best interests of the State. Reasons for not using the contract shall include but shall not necessarily be limited to the following: specific item is out-of-stock for an unreasonable amount of time (to be determined by the state agency) without an acceptable substitute; closest authorized dealer is too far and it would be burdensome for the agency to pay the cost associated with travel.
