Contract C311087001 has been awarded by the State of Missouri, Division of Purchasing and Materials Management and shall be subject to the following requirements:

- ✓ The contractor shall provide the recycling services for various State of Missouri state agencies located within the Kansas City, Missouri area on behalf of the State of Missouri, Office of Administration, Division of Purchasing and Materials Management, State Recycling Program. All references in the contract to the contracting agency of the City of Kansas City, Missouri or the "CITY" shall be deemed to refer to the contracting agency of the State of Missouri Recycling Program.
- ✓ The contractor shall provide recycling services for the locations specified on the list included herein as Attachment A. The contractor shall agree and understand that the list included on Attachment A shall not be construed as an all-inclusive listing of locations for which the contractor shall provide the services for the State of Missouri Recycling Program. The State of Missouri Recycling Program shall notify the contractor in writing of each added or changed location in the Kansas City, Missouri area.
- ✓ The contractor shall pay the State of Missouri State Recycling Program in accordance with the pricing specified in the contract for recycling collections from the various State of Missouri state agencies. The contractor shall submit payments and reports to: The State of Missouri Office of Administration, Division of Purchasing and Materials Management, State Recycling Program, PO Box 809, Jefferson City, MO 65102. The contractor must record and report collections from the State of Missouri locations, only.

- We are able to provide recycling containers at our cost to the City of KC.

Collection Units:

- **4-yd Dumpster**

The 4-yd dumpsters are spotted outside in dock areas or parking lots. These dumpsters measure 72" x 52" x 52" and are able to hold up to approximately one ton of paper. The pick up schedule for these dumpsters is automatic every other week or once a month. Batliner contracts out to Allied Waste for the pick up of these dumpsters. There is no charge for this dumpster.

- **Gaylord Boxes**

Gaylord boxes are for facilities that have a loading dock. These boxes sit on top of a 48" x 40" size skid. Batliner Paper supplies these boxes to the customer free of charge as long as we are receiving them back with material in them.

Minimum Requirements:

- Batliner Paper requires a minimum of 6 gaylord boxes for a pick up. There must be a minimum of 4 gaylords full of paper, not including cardboard. All additional gaylords can be cardboard/plastics. If a location is not able to hold for the minimum requirement we do have 4-yd dumpsters that can be placed outside of the facility for the collection of recyclables.
