

Missouri statutes (RSMo 67.360) authorized political subdivisions to use the services of the Missouri Division of Purchasing and Materials Management (DPMM). The DPMM has instituted this statute by allowing eligible political subdivisions the ability to place orders against certain statewide contracts. The following is a listing of those entities eligible to purchase from statewide contracts via the cooperative procurement clause. Terms and conditions of the statewide contract shall govern in case of discrepancy.
