

Scope of Plan

The Missouri ARRA Supplemental Statewide Cost Allocation Plan is an annual report prepared by the Office of Administration, Division of Accounting. The procedures and guidelines for the preparation of this report are contained in the United States Office of Management and Budget Circular A-87, "Cost Principles for State, Local and Indian Tribal Governments." The plan provides an allocation of actual fiscal year 2009 costs incurred after ARRA was signed as well as an estimate of fiscal year 2010 costs to be incurred.

The cost pools included in this plan are as follows:

Office of Administration - Rent Office of Administration - Fringes Office of Administration - Information Technology Services Office of Administration - Accounting ARRA Specific Employees - Salaries and Wages Office of Administration - Purchasing Office of the State Treasurer - Disbursements Contracted - Professional Services

For all cost pools included in this plan, only the costs incurred from state funds have been allocated. Federal fund expenditures have not been included in the original total cost for each cost pool. Allocations have been made to state agencies irregardless of their eligibility for reimbursement of central administrative indirect costs.
