#### **Purpose:**

The contracts identified herein have been awarded to serve State of Missouri agencies, political subdivisions or governmental entities specified by the State of Missouri for car rental services. The contracts are piggyback contracts off of NASPO ValuePoint contracts.

#### State Vehicular Travel Policy (SP-12) Requirements & Trip Optimizer:

The State Vehicular Travel Policy requires employees to take the lowest cost travel option for in-state travel. Please refer to the following website to view the State Vehicular Travel Policy: <a href="http://tripoptimizer.mo.gov/">http://tripoptimizer.mo.gov/</a>.

The Trip Optimizer is a tool to help agencies determine the most cost effective mode of in state travel between state vehicles, rentals, mileage reimbursement and Amtrak. State employees simply have to enter the number of trip days and round trip miles and the most cost effective travel option is displayed. #### **Accident Reporting Procedures:**

A driver involved in an accident in a state vehicle or rental vehicle should contact the nearest law enforcement official. Do not make any statement concerning assumption of liability. Give only the information required by the law enforcement authorities.

Collision damage and liability coverage are included in the daily rental rate. In the event of a serious accident where there is major damage to vehicles, property or bodily injury, please contact the Office of Administration, Risk Management Section to discuss whether the accident should be reported. In all cases, capture the following basic information: Names, addresses, vehicle registration, driver license number, and phone number of the other drivers and information on any other persons involved. Obtain insurance information from the other drivers. Record facts about the vehicle, property damage and any damage to other property. Get the names and addresses of all available witnesses to the accident.

Immediately contact the Enterprise renting branch listed on the pink copy of the rental agreement given to you at the time of rental, and complete an Enterprise Accident Report form. Do not sign any statements except those required by law enforcement officials, Risk Management or Enterprise. Report the accident to your state agency and contact OA Risk Management prior to completing the l Automobile Loss Notice Form # MO300-0068. If it is deemed necessary to report the accident to OA/Risk Management forward the completed form to Risk Management within two days. Request a copy of the police report and forward it to:

#### **Rental Reservations:**

#### The employee must rent the vehicle for official state use only.

#### **Identification Needed To Rent:**

At the time of rental Enterprise/National will ask the state employee to provide a current (i.e., not expired) Driver's License and may ask for valid state employee identification to confirm employment.

#### **Account Numbers:**

To obtain the contracted rental rate the employee should identify themselves as a State of Missouri employee and provide the name of their department and or account number.

#### **Direct Bill**

Enterprise/National provides direct billing services by establishing billing numbers associated with your departments main account number. This option is designed for departments with a Central Travel Desk. When Central Travel Desk Coordinators make reservations with an established billing number the rental charges will be applied to the departments associated Central Travel PCard or Traditional Direct Bill.

- Please reach out to your departments Central Travel Desk Coordinator or Central Travel PCard holder for reservations requests or best practices.
- To establish or update billing for your department please complete the billing application <u>found here</u>. Please allow 3-5 business days for processing.
- Enterprise employees do not have access to billing number information. Billing numbers must be provided during the reservation process online or over the phone for the rental to be billed.

#### **Other Payment Options**

State employees may still rent a vehicle for official state use by presenting a valid, un-expired drivers license, State of Missouri ID card and either a credit card or the State Procurement Card.

#### **Vehicle Fuel Level:**

At the time of pick-up the vehicle will be provided to the traveler with a full tank of fuel for rentals originating in the State of Missouri and at airport locations. Traveler shall return a vehicle to the rental branch with the same fuel level as the Vehicle had at time of pick up unless an alternative fuel arrangement was made at the time of vehicle pick up. Failure to do so will incur additional charges for refueling.

#### **Insurance:**

The daily rental rate includes all insurance coverages. Additional coverage does not need to be purchased on any type of rental.

#### **Enterprise Specific Information, continued**

#### **One-Way Rentals:**

- For home city one-way rentals originating and returning to branches located within the State of Missouri a \$25 drop fee will be charged.
- For home city one-way rentals originating and or returning out of the State of Missouri a \$125 drop fee will be charged
- Airport to airport one-way rentals will be charge the applicable one-way daily rate.

#### 15 Passenger Vans:

15 Passenger Vans are now included in the State of Missouri travel contract. Drivers must 25 years of age or older. Availability can be found online or by reaching out to the nearest Enterprise/National location.

#### Cargo Vans, Box Truck and other Commercial Vehicles.

#### **Taxes and Fees**

- Sales tax will be removed at the time of rental in markets where the State is exempt. Requests to remove sales tax on invoices that was charges in error can be email to ADRGatewayCity@ehi.com
- Local and state sales and federal excise taxes, airport concession fees, city surcharges or city differential fees applicable in certain cities, legislative or mandated taxes or fees, bond issues imposed by government bodies, similar charges controlled by third party(ies) and Vehicle Licensing fees are allowable.
- Enterprise will itemize those charges as separate line items on the rental agreement and add the charges to the base rate.
