The Governor recommends an additional \$40,000,000 federal stimulus funds for a summer learning program and programs to improve learning loss. Funds are available through the American Rescue Plan Act.

**New section to read as follows:**

Section 15.007. To the Department of Elementary and Secondary Education

For programs to improve learning loss provided that funds

may be used for but not limited to improving learning

loss by increasing access to the following: summer

school, tutoring, online or virtual learning programs, child

learning assessments, teacher training and materials or

other close the gap programs intended to improve

learning loss

**GOVERNOR'S RECOMMENDED AMENDMENT TO HOUSE BILL 3015 SECTION 15.072**

**Department: Elementary and Secondary Education**

---

**Explanation of Amendment:**

The Governor recommends an additional \$22,018,185 federal funds for child care subsidy payments. This is to expend carryover Child Care Development Funds (CCDF) prior to the federally imposed deadline of September 30, 2022 and provide relief to child care providers.

**New section to read as follows:**

Section 15.072. To the Department of Elementary and Secondary Education

For child care subsidy payments for low-income families,  
provided that the income thresholds for childcare  
subsidies shall be a full traditional subsidy benefit for  
individuals with an income which is less than or equal to  
150 percent of the federal poverty level; a transitional  
benefit of 80 percent for individuals with an income  
which is less than or equal to 185 percent of the federal  
poverty level but greater than 150 percent of the federal  
poverty level; a transitional benefit of 60 percent for  
individuals with an income which is less than or equal to  
215 percent of the federal poverty level but greater than  
185 percent of federal poverty level, and further provided  
that a traditional or transitional child care subsidy benefit  
regardless of previously qualifying for a traditional or  
transitional benefit for a child care subsidy, and further  
provided that the established sliding fee that provides for  
cost sharing by families that receive subsidy services be  
waived for the participant and paid by the department to  
providers from this appropriation; and to provide  
childcare subsidies for children under the care, custody,  
or involved with the Department of Social Services -  
Children's Division and children adopted or under legal  
guardianship through Children's Division, and further

provided that the subsidy paid by the Children's Division to providers on behalf of children in foster care shall be fixed to the market rate by region and provider-type, in accordance with the latest market rate study performed by or for the Division, and further provided that payments to providers shall be made in full and no more than two weeks in arrears

GOVERNOR'S RECOMMENDED AMENDMENT TO HOUSE BILL 3015 SECTION 15.277

Department: Corrections

**Explanation of Amendment:** The Governor recommends a \$3,000,000 increase to the Inmate Canteen Fund spending authority for the purchase of items for resale in the Inmate Canteens. The combination of inflation and increased offender spending has resulted in this appropriation shortfall.

**New section to read as follows:**

Section 15.277. To the Department of Corrections

For operating department institutional canteens for offender use and benefit. Per Section 217.195, RSMo, fund expenditures are solely to improve offender recreational, religious, or educational services, and for canteen cash flow and operating expenses.

GOVERNOR'S RECOMMENDED AMENDMENT TO HOUSE BILL 3015 SECTION 15.247

Department: Public Safety

**Explanation of Amendment:**

The Governor recommends an additional \$20,000 for the Funding for the Fallen Program to ensure that payments to survivors of local law enforcement officers, paramedics, emergency medical technicians, corrections officers, and/or firefighters who have lost their lives performing their duties are made in a timely fashion.

**New section to read as follows:**

Section 15.247. To the Department of Public Safety  
For the Office of the Director

To provide financial assistance to the spouses, children, and other dependents of any local law enforcement officers, paramedics, emergency medical technicians, corrections officers, and/or firefighters who have lost their lives performing their duties. Deaths from natural causes, illnesses, or injuries are outside the program's scope.

**Department: Office of Administration**

**Explanation of Amendment:**

The Governor recommends an additional \$3,584,610, including \$1,428,592 general revenue to various state-owned and institutional facilities in order to provide sufficient maintenance to these facilities. The combination of significant price increases in janitorial and security services, fuel, utilities, and shipping have resulted in this appropriation shortfall. The \$1,792,305 State Facility Maintenance and Operation Fund is a non-count appropriation.

**New section to read as follows:**

Section 15.172. To the Office of Administration  
 For the Division of Facilities Management, Design and Construction Asset Management  
 For any and all expenditures necessary for funding the  
     operations of state-owned office buildings and  
     institutional facilities  
 From State Facility Maintenance and Operation Fund.....\$      1,792,305

Section 15.512. To the Office of Administration  
 For the Division of Facilities Management, Design and Construction  
 For operation of state-owned facilities, utilities, systems  
     furniture, and structural modifications, provided that five  
     percent (5%) flexibility is allowed between Section  
     15.512 and 15.513, with no more than five percent (5%)  
     flexibility allowed between and within departments and  
     one hundred percent (100%) flexibility between federal  
     funds within this section
