Please reflect the Constitutional order of priorities when redistricting stated in Missouri Constitution Article III, Section 3, including Subsection (3) Dealing with Compact and Contiguous; and Subsection (4) of the same article, preserving communities of interest.

I would like to speak to the area I am most familiar. Recognizing that the 8th Senatorial District is going to have to shed some of the current district to maintain balance in the remaining Jackson County Districts.

I would like to suggest these community of interest boundaries:

- 1) that as nearly as possible you use I-70 as a natural boundary.
- 2) that the current 8th District encompass all of the South Eastern portion of the the county bounded by the Eastern and Southern boundaries of the county be a guide for preserving that community of interest as a nearly as possible
- 3) that the current 11th District encompass all of the North Eastern portion of the County Bounded by the North and Eastern boundaries of the county for preserving that community of interest as nearly as possible
  - 4) that within those general principles you preserve as many of the municipal boundaries as possible.
  - 5) suggestions for communities to be placed in Districts
- A) Blue Springs, Lees Summit as well as the other smaller communities that fall in that Southeastern area of the County be placed in current District 8
- B) Eastern Independence, Grain Valley and Oak Grove as well as the other smaller communities that generally fall in the Northeastern area of the County be placed in current District 11

Thank you for your work in administering the responsibility of the Missouri Constitution after the failure of the Independent Bi-Partisan Citizens Senatorial Commission to agree on a Map.

I have been a resident of Kansas City, Missouri since 1992.

As I am sure you know, the Missouri Constitution (Mo. Const. art. III, §3) requires the use of voting data averaged from statewide races for governor, United States Senate, and President for the past three general elections (2016, 2018, and 2020). These data sets are available at the precinct level on the Harvard Dataverse (Voting and Election Science Team 2021).

According to this data set, Missourians (in those statewide general elections) voted roughly 53.5% for Republicans and roughly 46.5% for Democrats.

I understand that Democratic voters are concentrated in the Kansas City and St. Louis areas, so it is understandable that the voting patterns in statewide elections would not simply comport proportionately across the state with the winners in elections for state senate districts.

In the current General Assembly, twenty four of the thirty four senate seats (70%) are held by Republicans.

This discrepancy (53.5% versus 70%) seems excessive to me. Perhaps there would be more competitive districts in the suburbs around the urban areas if lines were drawn with less partisan bias.

In late December, the house commission concurred on the lines for 112 districts in rural areas of Missouri. After those districts were off the table, they then focused on the remaining 51 districts in the Kansas City, Saint Louis, Boone County and Greene County areas.

Of course, I wasn't present for their deliberations, but I believe they could not have arrived at 100% accord unless they made liberal use of state-of-the-art technology which evaluated each map in terms of partisan fairness. Using that kind of tool, they could have made incremental changes in maps in the disputed areas until they arrived at a fair negotiation.

I fervently hope that you, as a commission, will work in a similar collaborative way to establish

partisan fairness in Missouri's senate.
