**Fiscal Year 2024 appropriations include funds for the following items:**

- \$100,000,000 Budget Stabilization Fund for maintenance and repair of minor and low volume routes.
- \$50,000,000 for design and construction of expansions and new National Guard buildings statewide, including \$5,000,000 general revenue.
- \$28,150,000 federal and other funds for statewide construction and improvements for the state park system.
- \$15,400,000 Conservation Commission Fund for new construction within statewide conservation areas including but not limited to: stream and lake site acquisition and development; improvements to buildings, roads, hatcheries, and other structures; and soil conservation and erosion control.
- \$15,000,000 Budget Stabilization Fund for a manufacturing and innovation center in St. Louis City.
- \$15,000,000 for the Great Rivers Greenway Project in the St. Louis Region to develop a regional network of greenways.
- \$14,302,907 Budget Stabilization Fund for chilled water loop system installation at the Fulton Reception and Diagnostic Center
- \$10,185,393 Budget Stabilization Fund for construction of a Department of Corrections southwest regional supervisory center.
- \$10,000,000 Budget Stabilization Fund for the planning, design, and construction for a public safety access point in the City of St. Louis.
- \$9,382,288 Veterans’ Commission Capital Improvement Trust Fund for the construction of a new columbarium wall at the Springfield Veterans’ Cemetery.
- \$7,500,000 Budget Stabilization Fund for the design and construction of an inpatient children’s acute psychiatric hospital located at a residential treatment facility in a St. Louis County.
- \$7,226,945 for construction of a new Department of Social Services, Division of Youth Services youth center in the St. Louis Region.
- \$6,332,837 Veterans’ Commission Capital Improvement Trust Fund for the construction of a new columbarium wall at the Higginsville Veterans’ Cemetery.
