Fiscal Year 2024 appropriations include funds for the following items:

- \$70,797,156 for public institutions of higher education for a 7% core increase.
 - \$11,330,433 for public community colleges:

 - \$2,500,000 and five staff to support the Preschool through Workforce (P20W) data systems.

 - \$1,000,000 for a nursing simulation laboratory facility for an online statewide nursing education program.
 - \$1,000,000 for a comprehensive counseling and solution generation service.

Vetoes in HB 3 include:

- (\$16,821,212) for a performance-based funding model.
- (\$15,000,000) for the University of Missouri eMINTS Program for prosocial education training initiatives for school districts and charter schools.
- (\$5,000,000) for the University of Missouri – Agriculture Extension Service.
- (\$1,000,000) for a comprehensive counseling and solution generation service.
- (\$600,000) for the Missouri Returning Heroes Program, including (\$400,000) general revenue.
- (\$408,536) for the State Historical Society.

Fiscal Year 2024 appropriations include reductions from the Fiscal Year 2023 core appropriation levels for the following items:

- (\$185,505,623) and (22.5) staff core reduction from the FY 2023 appropriation level, including (\$61,835) general revenue, including:
 - (\$131,665,160) other funds and (15.80) staff from the Missouri Student Loan Program due to the program ending.

- (\$32,659,448) Lottery Proceeds Fund for the A+ Schools Fund Scholarship transfer.
 - (\$16,416,667) Lottery Proceeds Fund for the Access Missouri Scholarship transfer.
 - (\$3,500,000) Lottery Proceeds Fund for the Academic Scholarship Program transfer.
 - (\$500,000) Economic Development Advancement Fund from an entrepreneurship program at Harris-Stowe State University.
 - (\$585,500) federal funds for completion of Certified Work Ready programs (GEER II).
 - (\$158,848) and (4.25) staff from Workforce Development to offset corresponding decision items, including (\$41,835) general revenue.
 - (\$20,000) from Workforce Development for a contract with the Tailor Institute.
- (\$77,630,103) core reduction for one-time expenditures, including (\$27,552,393) general revenue, including:
 - (\$31,496,061) Budget Stabilization Fund for the MO Excels Workforce Initiative.
 - (\$26,000,000) from public institutions of higher education.
 - (\$11,000,000) for distribution to Missouri State Employees' Retirement System (MOSERS) member public institutions of higher education for reimbursement of increased employer contributions.
 - (\$10,000,000) for community colleges.
 - (\$5,000,000) for the University of Missouri statewide operations in the areas of the Agricultural Extension Service.
 - (\$8,450,500) federal funds for distribution of Governor's Emergency Education Relief Funds II (GEER II).
 - (\$8,000,000) for completion of GEER Excels awards for projects that allow institutions to continue to provide educational services to students and to support economic recovery from COVID-19.
 - (\$450,000) for commissioning a performance funding study and an efficiency and reform study from which to provide recommendations to the Governor and General Assembly.
 - (\$5,000,000) Budget Stabilization Fund for development and implementation of a high school level geospatial training program accredited by the United States Geospatial Intelligence Foundation.
 - (\$1,000,000) Budget Stabilization Fund for a nursing simulation laboratory facility for an online statewide nursing education program.
 - (\$1,000,000) Budget Stabilization Fund for a program designed to help students from underrepresented communities transition from high school to software development careers in less than a year.
 - (\$1,000,000) Budget Stabilization Fund for an organization that provides cost-free digital skills training, reentry services, and provides workforce development and employment services in western Missouri.
 - (2.45) staff core reduction for unfilled vacancies.
