### Fiscal Year 2024 appropriations include funds for the following items:

- \$43,000,000 for a new veterinary medical diagnostic laboratory at the University of Missouri.
- \$25,000,000 for a new meat laboratory at the University of Missouri.
- \$1,660,000 for black vulture mitigation efforts.
- \$1,000,000 for a beef registry and database platform.
- \$1,000,000 for an agricultural education program administered by the Missouri Future Farmers of America Foundation.
- \$904,145 federal funds for control and management of infectious animal disease outbreaks.
- \$500,000 to support shortfalls in the Weights and Measures and Consumer Protections Program.
- \$354,780 other funds for fleet vehicle replacements and expansion.
- \$306,145 Grain Inspection Fee Fund and 11 staff for increasing grain and peanut inspections.
- \$250,000 for an urban agricultural educational development program in Kansas City
- \$250,000 for a youth agricultural entrepreneurship program in Kansas City.
- \$250,000 for a study to revamp Missouri's dairy industry.
- \$207,000 Agriculture Protection Fund to purchase feed laboratory equipment and analytic testing instruments.
- \$120,000 Lottery Proceeds Fund for student loans to large animal veterinarian students.
- \$104,378 and one staff for consumer protection compliance through the Meat and Poultry Protection Program, including \$69,589 general revenue.
- Two staff for state fairgrounds maintenance.

#### Vetoes in HB 6 include:

- (\$2,000,000) for a grant for agronomic and soybean breeding research.
- (\$2,000,000) for an adult agricultural leadership program.

## Fiscal Year 2024 appropriations include reductions from the Fiscal Year 2023 core appropriation levels for the following items:

- (\$2,309,628) and (seven) staff core reduction from the Fiscal Year 2023 appropriation level, including (\$2,000,000) general revenue, including:
  - (\$2,000,000) for export cattle operations at Lambert Airport.
  - (\$309,628) Industrial Hemp Fund and (five) staff to reflect the program being transferred to the US Domestic Hemp Production Program.
  - o (Two) staff to offset the addition of new staff.
- (\$466,500) federal and other funds core reduction for one-time expenditures, including:
  - (\$296,000) Agriculture Protection Fund for scale equipment for Weights, Measures, and Consumer Protections.
  - o (\$168,000) Agriculture Protection Fund for feed lab equipment replacements.
  - o (\$2,500) federal and other funds for equipment costs associated with new staff.

### Fiscal Year 2024 appropriations include funds for the following items:

- \$49,988,434 federal funds and one staff for an energy rebate program.
- \$30,000,000 for water infrastructure improvements in Lincoln County.
- \$25,000,000 for sewer improvement projects in Republic.
- \$17,200,000 federal funds to address emerging contaminants in public water systems.
- \$13,892,028 federal funds and one staff for investments to secure the state's energy grid.
- \$10,000,000 Soil and Water Sales Tax Fund for a cost-share program to address soil erosion and water quality impacts on agricultural land.
- \$6,000,000 for a sewer treatment facility in Strafford.
- \$5,500,000 for increased transfer to the Multipurpose Water Fund.
- \$5,000,000 for Mississippi levee and floodwall stabilization and improvements in St. Louis City.
- \$5,000,000 for sewer upgrades in Marshfield.
- \$5,000,000 for water infrastructure improvements and projects in Ellington.
- \$4,776,251 to pay for the state's obligation for the Superfund cleanup of contaminated sites.
- \$4,000,000 Soil and Water Sales Tax Fund for Soil and Water Conservation Districts' salaries and benefits.
- \$3,913,168 for water infrastructure improvements in Marshall.
- \$3,000,000 federal funds for air pollution control efforts.
- \$2,861,669 Hazardous Waste Fund pay for operation and maintenance for contaminated sites that have completed remediation.
- \$2,500,000 for construction and repairs of a bridge at Fellows Lake in Greene County.
- \$1,783,113 for low-interest loans and grants to communities for improvements to the drinking water infrastructure.

- \$1,033,334 for historic preservation grants and contracts.
- 4.4 staff to realign staffing between fund sources.

#### Vetoes in HB 6 include:

- (\$5,000,000) for Mississippi levee and floodwall stabilization and improvements in St. Louis City.
- (\$1,200,000) for sewer upgrades to a nursing care facility due to an incorrect county location reference; however, funding has been appropriated in House Bill 20.
- (\$869,000) for wastewater and stormwater projects in the Metropolitan St. Louis Sewer District.
- (\$565,525) for bank erosion improvements of Gravois Creek at Grantwood Village.
- (\$151,000) for stormwater upgrades to the Metropolitan St. Louis Sewer District.
- (\$75,000) for water infrastructure improvements in Elsberry.

# Fiscal Year 2024 appropriations include reductions from the Fiscal Year 2023 core appropriation levels for the following items:

- (\$2,148,714) core reduction for one-time expenditures, including (\$2,137,345) general revenue; including, but not limited to:
  - o (\$997,773) for Solid Waste Forfeitures.
  - o (\$619,416) for the Superfund transfer.
  - (\$332,387) for a Missouri river flood risk and resiliency study.
  - o (\$190,009) for the Clarence Cannon Dam water contract.
- (\$340,000) federal and other funds and (5.4) staff core reduction from the Fiscal Year 2023 appropriation level, including:
  - (\$120,000) other funds for state parks operations.
  - (\$100,000) federal funds for air pollution control grants.
  - o (\$50,000) federal funds for clean-up of controlled substances.
  - (\$50,000) Hazardous Waste Fund for environmental emergency response efforts.
  - o (\$20,000) Volkswagen Environmental Trust Fund for air pollution control efforts.
  - (4.4) staff to realign staffing between fund sources.
  - o (One) staff as duties were transferred to the Governor's Office for Mansion Director.

### Fiscal Year 2024 appropriations include funds for the following items:

- \$3,770,000 Conservation Commission Fund for an increase to employee health insurance premiums.
- \$3,642,000 Conservation Commission Fund for customer experience and employee engagement program improvements.
- \$1,726,000 Conservation Commission Fund for increased costs associated with habitat management operations.
- \$1,704,000 Conservation Commission Fund for fleet vehicle replacements.
- \$1,500,000 Conservation Commission Fund for an urban tree planting program.
- \$1,300,000 Conservation Commission Fund for various information technology and connectivity upgrades.
- \$918,841 Conservation Commission Fund for implementation of Missouri's Forest Action Plan.
- \$712,000 Conservation Commission Fund for increased costs associated with maintaining recreation conservation areas.
- \$561,000 Conservation Commission Fund for shipping cost increases.
- \$150,000 Conservation Commission Fund for community conservation programs.

# Fiscal Year 2024 appropriations include reductions from the Fiscal Year 2023 core appropriation levels for the following items:

- (\$552,500) Conservation Commission Fund core reduction for one-time expenditures, including:
  - (\$550,000) Conservation Commission Fund for heavy equipment replacements.
  - o (\$2,500) Conservation Commission Fund for equipment costs associated with new staff.
- (Four) staff core reduction due to unfilled vacancies.
