## STATEWIDE CONTRACT HISTORY

The following summarizes actions related to this Notification of Statewide Contract since its initial issuance. Any and all revisions have been incorporated into the attached document.

**1.1 Agency Determination for Award:**

- 1.1.1 At the time the state agency determines it needs for a trailer, all qualified vendors who can provide the specific product will be contacted to quote a firm, fixed price for the state agency’s specific purchase. **The contractor shall be obligated to quote a price at the time the state agency contacts the contractor for a quote.** The state agency will choose the lowest priced responsive vendor among the qualified vendors at the time of each trailer purchase. The firm, fixed price quoted for the specific purchase shall be contractually binding on the contractor for that specific order.
- 1.1.2 The contractor shall provide a trailer that meets all indicated specifications per the state agency’s request.
  - a. The contractor must also provide the state agency with a delivery time for the order.
- 1.1.3 Other factors that affect the determination of the lowest price qualified vendor include consideration of the Domestic Product Procurement Act, the Blind/Sheltered Workshop Preference and the Missouri Service-Disabled Veteran Business Preference explained in the paragraphs below.
- 1.1.4 The State of Missouri reserves the right to cancel the contract of a vendor who consistently fails to respond to the state agency’s requests for quotations.
- 1.1.5 Pricing shall be determined at the time of order. The contractor shall apply available discounts and other promotional pricing that may apply to the state agency’s order.

**1.2 Preference for Organizations for the Blind and Sheltered Workshops:**

- 1.2.1 Pursuant to section 34.165, RSMo, and 1 CSR 40-1.050, a five (5) to fifteen (15) bonus point preference shall be granted to contractors including products and/or services manufactured, produced or assembled by a qualified nonprofit organization for the blind established pursuant to 41 U.S.C. sections 46 to 48c or a sheltered workshop holding a certificate of approval from the Department of Elementary and Secondary Education pursuant to section 178.920, RSMo.
  - a. If the lowest priced vendor qualifies for the preference, or in the event none of the vendors qualify for the preference, no further calculation is necessary.
  - b. In the event the lowest priced contractor does not qualify for the preference but other contractors do at the time the state agency has solicited pricing for the spot purchase, then the following evaluation point formula shall apply to determine cost evaluation points for the specific spot purchase:

- 1) Preference points shall then be applied to the final cost point evaluations for all contractors qualifying for preference(s).

**1.3 Missouri Service-Disabled Veteran Business Preferences:**

- 1.3.1 Pursuant to section 34.074, RSMo, and 1 CSR 40-1.050, a three (3) bonus point preference shall be granted to vendors(s) who qualify as Missouri service-disabled veteran business enterprises.
  - a. If the lowest priced vendor qualifies for the preference, or in the event none of the vendors qualify for the preference, no further calculation is necessary.
  - b. In the event the lowest priced contractor does not qualify for the preference but other contractors do at the time the state agency has solicited pricing for the spot purchase, then the following evaluation point formula shall apply to determine cost evaluation points for the specific spot purchase:
