Missouri House Redistricting Commission

Maps Should Reflect Our Communities

My name is Marilyn McLeod. I live in Boone County in the 44th House District; Cheri Toalson-Reisch is my state representative and Caleb Rowden is my state senator. I have lived in Missouri for 42 years and am also current president of the League of Women Voters of Missouri.

I would first like to thank you not only for the opportunity to speak today, but also for the very respectful and well-run hearings that you have already held with the public. Moreover, I want to express my appreciation for scheduling additional hearings for parts of the state beyond the three main cities. I would also like to thank the Office of Administration for their work behind the scenes and the technical expertise in making these hearings available remotely for the public.

The League has long taken great interest in the redistricting process. The right to vote and the election process are our primary focus. The right to vote is the basis of all other rights. And in our democracy, the right to choose our leaders in our government is critical as the principal way to have the voices of citizens heard.

For decades, our nonpartisan organization has fought for fair and effective representation of our government. Fair maps give citizens a voice in their government. Maps based on total population are key to getting state and federal funding distributed equitably. Education, healthcare, business, infrastructure – all the elements of our lives can be affected by who is elected to represent us.

I know that several members of the League of Women Voters have testified and shared their stories of the areas they live in and the concerns they have for the redistricting process in prior hearings.

As said, I live in Boone County. Our population continues to grow, and the area is thriving. It serves as the crossroads of the state and has a major impact on people in our own and surrounding counties in mid-Missouri, with its medical facilities, university and colleges, businesses, restaurants, and the like. There are no closed storefronts in downtown Columbia.

We currently have five state representatives; two of them based completely in the county; three of them represent areas beyond Boone County; in fact, two of them have representation in four counties. The 2020 census lists Boone County with a population of 183,000 – this means that we should have four House representatives (approximately 38,000 people in each) completely in Boone County and one representative with some additional population from another county. This would reflect the requirements of compactness and contiguous districts.



We ask that districts be drawn in the public interest and not in that of any incumbent, potential candidate, or political party. Districts should reflect broad communities of interest, common to the population of an area. Maps must be based on total population data from the 2020 Census. As best as possible, draw competitive districts that don't give an unfair advantage to either political party and provide fair and equitable representation of all citizens regardless of age, race, background, zip code or income.

Fair district maps encourage legislators to put the concerns of the people they represent above donors and special interests. There should be more competitive elections that hold lawmakers accountable and give voters a stronger voice in our government. Citizens should select who represents them; politicians shouldn't select their voters.

We ask you to listen to demographic experts rather than incumbent politicians and party leaders. District maps can now be drawn with sophisticated software and analyzed for fairness. When draft maps are ready, we hope you will allow ample time for experts to analyze them and for Missouri citizens to provide input.

We greatly appreciate all the time and attention you are giving to this critical task that will shape the next decade for our state.

My name is Lyra Noce. I am a lifelong resident of Boone County, Missouri. I grew up in Southern Boone and lived in Columbia for many years. I obtained a bachelor's degree in Regional and Cultural Geography from the University of Missouri and then returned to Southern Boone to raise my family and that is where we currently reside within Missouri House District 50. I am familiar with the geographic identity of the County, the movement of populations over time within the County, as well as the difficult task the Commission faces making these new Missouri House District maps.

I have two requests for the Commission to consider:

First, that the population threshold of Boone County, Missouri has been met and it should be drawn into five concise House Districts within its border. The use of county borders to define districts is a commonly applied technique and it would benefit the citizens of Boone County for their House Districts to be drawn this way. The increased growth in this region should be considered an important factor in this decision. The citizens of Boone County should not have their voices diluted by populations outside the county line who do not utilize the same services or face the same challenges as a growing metro region.

Secondly, residents of Southern Boone have been negatively impacted by the poorly drawn House Districts for the last decade. House District 50, as it is currently drawn, stretches from southern Columbia, to northern Cole County, to California, Missouri in Moniteau County and portions of Cooper County. I can count on one hand the number of times I have been to California, Missouri. This is because the district is not accessible nor connected. I have to leave the district entirely to traverse the Missouri River by bridge on Highway 63 or Interstate 70 to access the southern portions. This separation within the district breeds disconnect, lack of understanding of local issues, and the loss of our voice in Jefferson City. The communities of Southern Boone, Ashland, Hartsburg, Easley, Englewood, and Pierpont to name a few are integrally tied to the City of Columbia and bound by the border of the Missouri River.

We have seen a migration of populations to our County over the last decade. Boone Countians center their lives around the growing city of Columbia. As the largest metro area in Boone County as well as the region, it provides the majority of shopping, leisure activities, higher education opportunities, access to health care, and employment for our citizens.

I urge the commission to consider the physical barrier of the Missouri River and draw the entirety of District 50 within Boone County. I implore the Commission to draw the borders of all five expected Missouri House Districts within the boundary of the County of Boone.
