A properly executed warranty will be furnished with the delivery of each vehicle. The warranty will not become effective until the ATV and UTV are placed into service. State agencies are to notify the contractor of the "in-service" date for each ATV and UTV.

**Title and Certificate of Origin:**

The title and certificate of origin must be included with the delivery of the ATV or UTV. The certificate and title application must be made as required by the state agency purchasing the unit.

**Delivery Performance:**

Delivery times shall be as indicated herein. All deliveries must be coordinated with the state agency.

Deliveries shall be made to the location as specified on the purchase order.

**Substitutions:**

No items shall be substituted unless approved by Purchasing.

**Replacement of Damaged Product:**

Any item receive in damaged condition shall be replaced at no cost to the State of Missouri. This includes all shipping costs for returning non-functional items to the contractor for replacement.
