Delivery times shall be as indicated herein. All deliveries must be coordinated with the state agency.

Deliveries shall be made to the location as specified on the purchase order.

Substitutions:

No items shall be substituted unless approved by the Division of Purchasing.

Replacement of Damaged Product:

Any item received in damaged condition shall be replaced at no cost to the State of Missouri. This includes all shipping costs for returning non-functional items to the contractor for replacement.
