more than twenty-seven thousand but fewer than thirty thousand  
inhabitants and located in a county with more than one million  
inhabitants associated with a not-for-profit law enforcement  
organization located in a city with more than eight thousand but  
fewer than nine thousand inhabitants and located in a county  
with more than one million inhabitants, provided that any grant  
awards disbursed from this appropriation shall be matched on a  
50/50 basis by the recipient
