 - a. ADD Note No. 1: “Flooring in Alternate 3 scope of work is on structural concrete slab on grade. Flooring in all other areas in kitchen is on structural concrete floor above floor below.”
2. SHEET D100 – Kitchen Floor Demolition Plan
 - a. REVISE Keyed Note No. 7: “Remove existing sink equipment and prepare for new sink to be plumbed in. New sink is purchased and will be installed by Owner. Coordinate schedule for removal of existing sink with Owner.”
3. SHEET A104 – Kitchen Floor Plan-Alternate 2
 - a. ADD Keyed Note No. 3: “Stainless steel wall and new sink equipment to be installed by DOC at the time of construction. Coordinate construction schedule with DOC prior to new flooring installation.”
