Please be advised that all manufacturers of material suppliers required to be identified on the Proposed Subcontractor form, Section 004336, must be an approved manufacturer or material supplier as outlined in the bid specifications or in a written addenda in accordance with Section 4.0 of the Instructions to Bidders. Any bids received listing an unapproved manufacturer or material supplier will be considered non-responsive and shall be rejected.

DRAWING CHANGES:

2. Sheet C-102

- a. ADD the following general note:

“Note: The installation of the new grinder station will require bypass pumping as noted on the plan sheet. This bypass can be accomplished by a temporary bypass sump to the existing screen or to the downstream manhole #2. It is the contractor’s option if they wish to incorporate a new doghouse manhole in lieu of a pre-manufactured (all in one) grinder station as part of their bid.”
