  - a. REVISE Hot Water Coils Schedule as follows:
    1. Mark No. "HV-H1" shall read "HV-H1, HV-H4, HV-H5". HV-H4 coil will require a 3-way valve and HV-H5 coil will require a 2-way control valve.
    2. HV-C1, HV-C2, and HV-C3 coils in the air handling unit are not shown on mechanical plans but are located in the Central Services Building. Please include pricing for the coils.
