1. SECTION 321816.13 – PLAYGROUND PROTECTIVE SURFACING

a. ADD Paragraph 2.1-A.1.d as follows:

GENERAL COMMENTS:

1. Previously distributed plans and specifications with issue date of March 11, 2020 and Addendum No. 1 dated April 23, 2020, Addendum No. 2 dated May 5, 2020, Addendum No. 3 dated May 7, 2020, and Addendum No. 4 dated May 21, 2020 still apply for this project. 2. **All bids shall be submitted on the revised bid form (provided in Addendum No. 4) without additional terms and conditions, modifications, or stipulations. Each space on the bid form shall be properly filled including bid amounts for each alternate. Failure to do so will result in rejection of the bid.**
3. **Drug policy requirements can be found in SECTION 013513.13 Drug & Alcohol Testing Program Contractual Requirement – (1 CSR 30-7.010). Each bidder shall furnish a copy of its drug and alcohol testing program and certify that it and its' subcontractors comply with the provisions of this rule. Failure to submit this with the bid submittal will result in rejection of the bid.**
4. **MBE/WBE/SDVE participation requirements can be found in DIVISION 00. The MBE/WBE/SDVE participation goals are 10%/10%/3%, respectively. Only certified firms as of the bid opening date can be used to satisfy the MBE/WBE/SDVE participation goals for this project. If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.**
