3.3 – Cover Letter of Interest:

Add the following:

If submitting as a Joint Venture, partners from all firms need to provide signatures on the Cover Letter of Interest. The official company name of the Joint Venture as registered with the Missouri Secretary of State's office must be outlined in the Cover Letter of Interest.

3.4 Tab 1 – Team Organization and Proposed Project Team:

REVISE c. as follows:

"Provide a bar chart illustrating the timing, duration, and percentage of all the Firm's core personnel assigned to the proposed Project team."

3.5 Tab 2 – Team Capacity and Experience:

REVISE b. as follows:

"Provide additional resumes of alternate core personnel and explanation of the Firm's capacity to substitute key positions in the event of unavoidable personnel changes."

3.7 Tab 4 – Past Performance

REVISE a. as follows:

"Identify, summarize, and provide references on a minimum of three (3), but no more than five (5) projects of similar size and scope, which have reached construction completion, within the last ten (10) years by the Lead Firm.

3.9 Tab 6 - Current Projects and Workload

REVISE b. as follows:

List all proposed team members assigned to each of the referenced projects to demonstrate current workload and future capacity for this project.

ADD as follows:

"c. In the case that a list of all projects will exceed the request page limit, it is acceptable to submit an outline of projects in which the proposed team members are involved and their percentage of time allotted to each project."

3.10 Tab 7 – Financial Stability

REVISE b as follows:

Provide evidence from the lead Firm's insurance carrier supporting their ability to provide adequate Professional Liability Insurance in the amount of five percent (5%) of the total Allowable for Construction or \$5,000,000 for each claim and \$5,000,000 in the annual aggregate, whichever is less. The policy shall contain an endorsement that the Owner will receive written notice thirty (30) days in advance of any policy cancelation, termination or material change. In the event the insurance policy is written on a "claims made" basis, coverage

shall extend for two (2) years past the completion of the project. Any companies submitting as a Joint Venture must include the official name registered on the Missouri Secretary of State's website in the letter from their insurance carrier.

3.11 Format for SOQ Submissions

REVISE b. as follows:

"Ten (10) spiral bound hard copies consisting of a maximum of forty (40) double-sided 8 ½ x 11 pages (or 80 total pages), not including the letter of interest, table of contents, organizational chart and bar chart, personnel resumes/qualifications, financial information, covers and dividers.

12.9 Joint Ventures

Add the following:

Joint Ventures must be properly registered and approved with the Missouri Secretary of State's office at the time of the SOQ evaluations, as provided in Section 417.200, RSMo. An agreement will only be issued to the company name approved with the Missouri Secretary of State's office, provided all other requirements are met.
