SPECIFICATION CHANGES:

- 1. Section 13300 Submittals
 - a. DELETE the following submittal from Paragraph 3.1 REQUIRED SUBMITTALS:

312100 Rock Excavation (Class B) Test Report

- 2. Section 311000 Site Clearing
 - a. ADD the following to Paragraph 3.4 CLEARING:
 - F. Clearing and grubbing waste shall be burned on-site or mulched under State Park supervision.
 - G. Contractor may not remove trees between April 1 and September 30 due to species listed under the federal endangered species act. Missouri Department of Conservation must be contacted prior to work starting.
- 3. Section 312000 Earthwork
 - a. REVISE Paragraph 1.2 QUAILTY ASSURANCE as follows:
 - A. An Independent Testing Laboratory (ITL), selected and paid for by the Contractor, will be retained to perform construction testing on site.
 - The ITL shall prepare test reports that indicate test location, elevation data, and test results. Owner, Engineer, and Contractor shall be provided with copies of reports within 96 hours of time that test was performed. In event that test performed fails to meet Specifications, the independent testing laboratory shall notify Owner and Contractor immediately.
 - Costs related to retesting due to failures shall be paid for by the Contractor at no additional expense to Owner. Contractor shall provide free access to site for testing activities.
 - 3. Quality assurance testing will be conducted in accordance with Paragraph "Field Testing" in Part 3 hereinafter.
 - b. DELETE Paragraph 1.3-C in its entirety.

- c. DELETE Paragraph 3.4-A.2 in its entirety.
- d. ADD the following to Paragraph 3.4 GENERAL EXCAVATION
 - H. Spoils from the site shall be hauled to the spoils site located on State Park property as depicted by State Park Personnel.
