- 7. Prospective Bidders contact American Document Solutions, 1400 Forum Blvd., Suite 7A, Columbia, Missouri 65203, 573-446-7768 to order official plans and specifications.
- 8. All bids shall be submitted without additional terms and conditions, modification or reservation on the bid form with each space properly filled. Bids not on these forms will be rejected. Failure to do so will result in rejection of the bid.
- 9. MBE/WBE/SDVE participation requirements can be found in DIVISION 00. MBE/WBE/SDVE Goals: MBE 10%, WBE 10%, and SDVE 3%. NOTE: Only MBE/WBE firms certified by the State of Missouri Office of Equal Opportunity as of the date of bid opening, or SDVE(s) meeting the requirements of Section 34.074, RSMo and 1 CSR 30-5.010, can be used to satisfy the MBE/WBE/SDVE participation goals for this project. No other certifications from other Missouri certifying agencies will be accepted. If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.
- 10. The project site is less than one acre, so no DNR land disturbance permit is required. Plans require erosion and sediment control devices around each site.
- 11. The contractor is responsible for engaging a qualified testing firm for all testing and inspection of materials.
- 12. Contractor is responsible for obtaining Building permit from the Osage Beach Fire Protection District for each yurt and the lodging permit from Missouri Department of Health and Senior Services for each yurt.
- 13. The decks for the yurts are designed around the yurt. The yurt floor shall not be placed on the deck, but on a separate system as recommended by the manufacturer.
- 14. Contractor coordination is required as there will be two other construction projects occurring within the park at the same time. A waterline project will pass through this project. Approaches to parking spots were designed to allow the waterline.
- 15. Reservations for the camp sites will be halted on 10/31/24. Construction can begin on 11/1/24. It was reiterated that there was no burning in the park. Trees would have to be removed off site.
- 16. The contractor is to provide any additional surveying.
- 17. Contractor to coordinate with Parks staff if boring under the road for electrical as there is a force main running under the roadway.
- 18. Parks staff will put Owner supplied furniture together. The contractor is responsible for installing the furniture.




