SPECIFICATION CHANGES:

1. Section 357313 – Earth Dam Embankment
 - a. REVISE Paragraph 3.9-L as follows:
 - L. Anti-Seep Collar(s), Rigid in Design, shall be constructed from durable 1/4" High Density Polyethylene Plastic (HDPE), similar in construction to Scheib Drainage Products™ - SKU: ANTISEEP4X4X18. Contractor is also responsible for ensuring all Anti-Seep Collars are compatible with pipe and are installed as per manufactures recommendations.

Only certified firms as of the bid opening date can be used to satisfy the MBE/WBE/SDVE participation goals for this project. If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.
