Bidders are hereby informed that the construction Plans and/or Specifications are modified as follows:

SPECIFICATION CHANGES:

1. Section 011423 - Work Restrictions

a. ADD the following to Paragraph 3.03-F: "The Contractor shall be responsible for dewatering the existing standby clarifier and transferring its contents to the aeration basis to allow the clarifier to be used for temporary waste sludge storage."

2. Section 444629.13 – Sludge Pump (Submersible Type)

- a. ADD the following to Paragraph 2.03-C.2: "All alarm indicators shall be mounted on the control panel enclosure inner door."
- b. REVISE Paragraph 2.03-E.4.b as follows: "Properly sized for connected load. Existing 3-phase power supply is 115/208 V 4-wire system. See Sheet C-501 Detail A."
- c. ADD the following to Paragraph 2.03-E.8: "Red Pilot to indicate Adjustable Frequency Drive (AFD) fault/failure. Mount all pilot lights on the control panel inner door."
- d. REVISE Paragraph 2.03-E.10.c.1) as follows: "Control circuit wiring inside panel, except internal wiring of individual components, shall be 16 gauge minimum. Power wiring shall be 12 gauge minimum."

DRAWING CHANGES:

1. Sheet C-507, Details 1 & 2

a. ADD the following General Note: "The Owner's plant operations staff will be responsible for removal and cleanup of chemical (Ferric Chloride) spills in the existing chemical feed building prior to the Contractor performing any work inside the building. Attached for informational purposes is a copy of the chemical supplier's Material Safety Data Sheet (MSDS)."

2. Sheet E-501, Detail 2

a. ADD a 20 amp 1-pole circuit (LP-7) from Panelboard LP to service the Sludge Dewatering System Electrical Control Panel specified in Section 444616 Part 2.06. Control Panel shall be mounted on the west wall adjacent to the Duplex GFI (LP-4).
