### **SPECIFICATION CHANGES:**

- 1. Section 230923 Direct Digital Control (DDC) System for HVAC
  - a. REPLACE Section 2.3.A as follows:
    - A. Connect to existing Schneider Electric System Web-based DDC system to control the Chiller Plant, Multi-zone AHU, and all other HVAC equipment as required to meet the requirements described in 230993.11 Sequence of Operations for HVAC, DDC specification section. Connect the system into the building's LAN network. Provide web-based access to the system, using a graphical interface. All communications between the web-based controller and the field controllers shall be BACnet. All controls work shall be coordinated with Corey Schepers with C&C Group at 913-530-7369, Email: Cschepers@c-cgroup.com.

#### 2. Section 230993.11 Sequence of Operation

- a. REPLACE Section 3.1.A.2.b as follows:
  - b. The chiller is not required to have automatic isolation valves.
- b. REPLACE Section 3.1.B.2 as follows:
  - 2. Return Fan Control-There is not a return fan in the air handling unit, so no control is necessary.
- c. REPLACE Section 3.1.B.6 as follows:
  - 6. Cold Deck Control: The cold deck for air handling unit needs to have 3-way valve as shown on plans. When the outside enthalpy rises above the enthalpy economizer setpoint, the outside dampers will be driven to the minimum position setting. The cold deck temperature will be reset based on the warmest zone (space) temperature according to the following schedule: Warmest Zone 74 deg-Cold Deck-55 deg. Warmest Zone 72 deg-Hot Deck 65 deg.
- d. REPLACE Section 3.1.B.7:
  - 7. Zone Control (6 Zones) Each zone damper actuator will modulate to maintain the space zone temperature.

- 1. Sheet M-100-Mechanical Demolition Plans Building HU-1 (Alternate #1), HU-2 & HU-3
  - a. REPLACE Floor Plan DM Note 1 as follows:
    - 1. Remove Electric Operated Damper and cap and seal opening air and water tight with insulated metal clad panel. There is an opening on lower and upper floor for a total of two in each location shown on plan. There are a total of sixteen (16) openings in the whole building. RE: Louver Seal Detail on Sheet M-300.
  - b. ADD Floor Plan DM Note 3 as follows:
    - 3. Provide air and water balance report for existing air handling unit to engineer to review and approve prior to ordering new air handling unit.
- 2. Sheet M-302-Mechanical Schedules, General Notes & Symbols
  - a. REVISE Chiller Schedule (Air Cooled) Note No. 2 as follows:
    - 2. Provide with dual pump package with constant volume package with a total of 70 ft. of head pressure loss.
  - b. ADD Chiller Schedule (Air Cooled) Note No. 7 as follows:
    - 7. Selection made with 30% propylene glycol.
  - c. REVISE Multizone Air Handling Schedule's Heating Coil Flow (GPM) as follows:

47.2 GPM.

- d. ADD Multizone Air Handling Schedule Note No. 7 as follows:
  - 7. Selection made with 30% propylene glycol.
- e. ADD Multizone Air Handling Schedule Note No. 8 as follows:
  - 8. Provide air flow monitoring station for all air handling units outside air duct.
