  - a. ADD Paragraph 2.2, A, 7. Wilo-Stratos.
- 3. Section 235216 Condensing Boilers:
  - a. ADD Paragraph 2.1, A, 9. Riello North America.

#### **DRAWING CHANGES:**

- 1. Sheet MD201:
  - a. MODIFY Keynote MD17 as follows:

Asbestos shall be assumed to be present in the existing boiler. Asbestos remediation shall be preformed prior to removing the boiler from the mechanical room. Remove existing boiler, flue, controls, and accessories. Remove associated water and natural gas piping, and electrical connections as required to facilitate the proposed boiler installation shown on subsequent sheets.
