 - a. REVISE Paragraph 3.0-A as follows:
 - A. Until: 1:30 PM, Thursday, November 17, 2022
- 2. Section 024119 Selective Demolition
 - a. ADD Paragraph 3.5-B as follows:
 - B. Drywall at device locations: When relocating devices from original locations, patch drywall holes and paint to match existing. When relocation from existing junction box, install cover plate and paint to match existing.
- 3. <u>Section 284621.11 Addressable Fire Alarm Systems</u>
 - a. ADD Paragraph 2.3-A.5 as follows:
 - 5. Siemens Industry Inc.
 - b. REVISE Paragraph 2.4-B as follows:
 - B. General Requirements for Manual Fire-Alarm Boxes: Comply with UL 38. Boxes must be finished in red with molded, raised-letter operations instructions in contrasting color; must show visible indication of operation; and must be mounted on recessed outlet box. If indicated as surface mounted, provide manufacturer's surface back box. Install with tamper proof screws where screws are exposed when devices are installed within client spaces or hallways of client wings.
 - c. REVISE Paragraph 2.5-A.2.b.3) as follows:
 - 3) Base Mounting: Detector and associated electronic components must be mounted in twist-lock module that connects to fixed base. Provide terminals in fixed base for connection to building wiring. Install with tamper proof screws where screws are exposed when devices are installed within client spaces or hallways of client wings.

- d. REVISE Paragraph 2.8-A.3.b.3) as follows:
 - 3) Combination Devices: Factory-integrated audible and visible devices in single mounting assembly, equipped for mounting as indicated, and with screw terminals for system connections. Install with tamper proof screws where screws are exposed when devices are installed within client spaces or hallways of client wings.
- e. REVISE Paragraph 2.8-B.2.b.3) as follows:
 - Mounting: Wall mounted unless otherwise indicated. Install with tamper proof screws where screws are exposed when devices are installed within client spaces or hallways of client wings.
- f. REVISE Paragraph 2.9-B.2.a.1) as follows:
 - Mounting: Surface cabinet, NEMA 250, Type 1. Install with tamper proof screws where screws are exposed when devices are installed within client spaces or hallways of client wings.
