GENERAL NOTES:

- 1. THIS PROJECT IS A REMOVE AND REPLACE TYPE OF CONSTRUCTION. AS SUCH, THE AREA DOES NOT HAVE DETAILED GRADING DESIGN, AS THE REPLACEMENT PAVING WILL MATCH EXISTING PAVEMENT.
- 2. ALL WORK ON THE CITY OF JEFFERSON RIGHT OF WAY, PRIMARILY THE STREET CONNECTIONS, REQUIRES THAT THE CITY OF JEFFERSON DEPARTMENT OF PUBLIC WORKS BE NOTIFIED PRIOR TO BEGINNING WORK. THE WORK WILL REQUIRE LANE SHUTDOWNS, AND THE CITY MAY REQUIRE A TRAFFIC CONTROL PLAN. THE CONTRACTOR SHALL BE RESPONSIBLE FOR PRODUCING THIS PLAN FOR THE CITY'S APPROVAL AND SHALL BE BASED UPON THE CONTRACTOR'S MEANS AND METHODS. THE CONTRACTOR SHALL OBTAIN ALL NECESSARY PERMITS REQUIRED BY THE CITY.
- 3. THE CONTRACTOR SHALL ENGAGE A PRIVATE UTILITY LOCATE SERVICE IN AREAS WHERE PAVEMENT REPLACEMENT WILL TAKE PLACE.
- 4. A SEPARATE DEMOLITION PLAN HAS NOT BEEN DEVELOPED AS MOST AREAS CONSIST OF REPLACEMENT PAVING AND CURBING TO MATCH EXISTING.
- 5. THIS PROJECT WILL REQUIRE EXTENSIVE PHASING AND COORDINATION WITH THE OWNER AND CITY. THE CONTRACTOR WILL WORK WITH THE OWNER AND CITY TO DEVELOP A PHASING PLAN.THE CONTRACTOR SHALL KEEP EITHER THE NORTH SIDE (WESTBOUND LANES) OR THE SOUTH SIDE (EAST BOUND LANES) OPEN WHILE WORKING ON THE OTHER SIDE.
- 6. ALL DEMOLISHED MATERIALS SHALL BE REMOVED FROM SITE DAILY AND LEGALLY DISPOSED OF.
- 7. THE CONSTRUCTION AREA SHALL BE MAINTAINED BY THE CONTRACTOR IN A CONDITION THAT WILL PREVENT TRACKING OR FLOWING OF SEDIMENT ONTO PUBLIC RIGHT-OF-WAYS AND STREETS THAT HAVE BEEN SOILED BY CONSTRUCTION ACTIVITIES SHALL BE CONTRACTOR'S RESPONSIBILITY.
- 8. PAVEMENT SHADED AS ON SITE PLAN SHALL BE COLD MILLED TO A DEPTH OF 2" AND OVERLAID WITH ASPHALT PAVEMENT, APPROXIMATELY 12,659 SQUARE YARDS. THE CONTRACTOR IS RESPONSIBLE FOR VERIFYING ALL QUANTITIES AND NO ADDITIONAL PAYMENTS WILL BE MADE IF FINAL QUANTITIES DO NOT MATCH PLANS.
- 9. CONTRACTOR SHALL PROVIDE FULL DEPTH PAVEMENT REPAIRS AS DETERMINED BY THE OWNER AFTER COLD MILLING IS COMPLETE/PER PAVEMENT REPAIR DETAIL ON SHEET A-501. 3,000 SQUARE YARDS OF FULL DEPTH PAVEMENT REPAIRS IS INCLUDED IN THE BASE BID.
- 10. CONTRACTOR SHALL PAINT PAVEMENT MARKINGS AND CONCRETE CURBS TO MATCH EXISTING LAYOUT OR AS DETAILED ON PLAN SHEETS.
- 11. ALL EXISTING SIGNS/POSTS AFFECTED BY CONSTRUCTION SHALL BE REMOVED, STORED, AND RE-INSTALLED AS NEEDED FOR PAVEMENT REPLACEMENT.
- 12. THE CONTRACTOR IS RESPONSIBLE FOR ALL BARRICADES REQUIRED FOR SAFETY IN AND AROUND THE CONSTRUCTION SITE.






TRANSITION DETAIL SCALE: NTS




PAVEMENT REPAIR DETAIL SCALE: NTS
