9. **All bids shall be submitted on the bid form without additional terms and conditions, modifications, or stipulations. Each space on the bid form shall be properly filled. Failure to do so will result in rejection of the bid.**
10. **MBE/WBE/SDVE participation requirements can be found in DIVISION 00. The MBE/WBE/SDVE participation goals are 10%/10%/3%, respectively. Only certified firms as of the bid opening date can be used to satisfy the MBE/WBE/SDVE participation goals for this project. If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.**

SPECIFICATION CHANGES:

1. Section 024119 - SELECTIVE DEMOLITION
 - a. DELETE Paragraph 3.5-A in its entirety and REPLACE with the following:

- A. All existing **Pergola Timbers** including the 4x6 cross members, the 4x12 main beams and the 2x light fixture base plaques shall be carefully removed, salvaged and turned over to the Owner to be retained as their property. Contractor shall deliver these materials to the Owner's property at 1635 Industrial Drive and unload in appropriate stacks as directed by the Owner. All other Wood Carpentry such as items from the **Cornice Sections** of the Pavilion shall be carefully removed so as not to damage adjacent construction or the removed components. Observe, measure and record existing wood component sizes, shape, joints and splices so that these conditions can be replicated in the new construction. All removed wood components from the Cornice Sections shall become the property of the Contractor to dispose of properly.
