EXHAUST FLUE MUST EITHER BE CATEGORY IV APPROVED STAINLESS STEEL SEALED VENT MATERIAL FROM ONE OF THE APPROVED MANUFACTURERS LISTED IN THE INSTALLATION AND OPERATION MANUAL OR POLYPROPYLENE PIPED AS PER MANUFACTURER'S REQUIREMENTS. PVC SHALL NOT BE PERMITTED IN ANY PART OF THE VENT PIPING CONSTRUCTION. BOILERS EXHAUST VENT LENGTH MUST BE ABLE TO EXTEND TO 100 EQUIVALENT FEET.
