Bidders are hereby informed that the construction Plans and/or Specifications are modified as follows:

SPECIFICATION CHANGES:

1. Section 011000 - Summary of Work
 - a. REVISE Paragraph 1.6, C, 1 as follows: Wing “A” can be fully closed off temporarily during construction (coordinate this closure with the Facility, and comply with requirements indicated in Section 015000 - Construction Facilities and Temporary Controls). However, other exit corridors within the building where work is shown to take place must maintain 42" clear at all times.
2. Section 015000 - Construction Facilities and Temporary Controls
 - a. DELETE Paragraph 2.2, H
 - b. DELETE Paragraph 3.2, K
 - c. DELETE Paragraph 3.2, N
 - d. DELETE Paragraph 3.2, P
 - e. DELETE Paragraph 3.2, Q

DRAWING CHANGES:

1. SHEET M-001
 - a. ADD following note to box note located below “Scheduling and General Notes for Hydronic Piping”: “Existing hangers and supports shall be replaced with new for all new piping.”
2. SHEET M-005
 - a. ADD following note to box note located below “Scheduling and General Notes for Hydronic Piping”: “Existing hangers and supports shall be replaced with new for all new piping.”
3. SHEET M-012
 - a. DELETE “FCUW2” from 4-Pipe Fan Coil Unit Schedule.

4. SHEET E-004

- a. ADD following General Note: Contractor shall provide all hardware and software upgrades necessary to tie new equipment into the existing fire alarm system.

9. **All bids shall be submitted on the bid form without additional terms and conditions, modifications, or stipulations. Each space on the bid form shall be properly filled including a bid amount for the Unit Prices. Failure to do so will result in rejection of the bid.**
10. **MBE/WBE/SDVE participation requirements can be found in DIVISION 00. The MBE/WBE/SDVE participation goals are 0%/0%/3%, respectively. Only certified firms as of the bid opening date can be used to satisfy the MBE/WBE/SDVE participation goals for this project. If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.**
11. **The Contractor shall pay not less than the prevailing hourly rate of wages for work of a similar character in the locality in which the work is performed, as determined by the Missouri Department of Labor and Industrial Relations. Bidders are to adhere to Prevailing Wage Hourly Rate of Wages, and the Department of Labor and Industrial Relations can be contacted to determine the applicable wage rate for the work on this project.**
