DRAWING CHANGES:

1. Sheet C-100

- a. ADD the following General Notes:
 - 28. Trees to be removed will be pushed over by State Park staff prior to March 31, 2023. Contractor is responsible for removal of said trees from the property per the plans and specifications.
 - 29. Vehicles in excess of legal or posted loads will need to apply to the State Parks for permission to cross park-owned structures. Where necessary on public roads, permits should be applied to MoDOT according to state regulations. The Campground Bridge over the Current River (Bridge ID 25309) is currently posted at 15 tons and is owned by the State Park. The Park has had an inspection and load rating completed with an assumed oversized load for a precast shower structure (on the Loop #5 project), which weighed 63 tons and was 53 feet long. The finding was that this assumed vehicle did not violate the operating rating, so individual permit passage would be allowed under strictly controlled conditions. The State Park's engineer will review the Contractor's proposed vehicles, re-run the rating with the actual Contractor's vehicles, and facilitate a permit and/or convey limitations as a preconstruction work item. Contractors should assume time for this coordination effort and that vehicles in excess of legal or posted loads may need to utilize flaggers to restrict the bridge to a single lane or strictly observe limitations on speed, and this work should be factored into their bids. 




