SPECIFICATION CHANGES:

- 1. Section 330516 Precast Concrete Utility Structures
 - a. ADD the following sentence to Paragraph 2.10-I:

The Xypex Bio-San C-500 Antimicrobial Crystalline is considered an equal product in lieu of the two products Conshield ConmicShield Antimicrobial additive and ConmicShield ID. Also, the Xypex Mega Mix II with Bio-San is considered an equal product in lieu of the Conshield ConmicShield joint set grout.

DRAWING CHANGES:

- 1. Sheet G-005
 - a. REVISE the New Influent MH WSE to 851.71 ft.
 - b. REVISE the Tank No. 1 10,000 Gallons (SEPTIC TANK 1) WSE to 851.41 ft.
 - c. REVISE General Note 1 as follows:
 - 1. The hydraulic profile is based on all units in service at the plant peak flow rate of 18,244 gpd.

2. Sheet C-104

- a. ADD General Note 6 as follows:
 - 6. Contractor is responsible for removal and disposal of trees. Contractor to coordinate with Owner. Tree removal, where lateral fields are installed, shall include full removal of trees including stumps and roots.

Sheet C-106

- a. ADD General Note 7 as follows:
 - 7. Lateral field fill shall meet a minimum LTAR of 0.25 gpd/ft2. Soil can be Soil Group I or II. The soil texture can be sand, loamy sand, sandy loam or loam per MO 19 CSR 20.3.060 Table 14 for Soil Group and Application Rate Data. Contractor shall have the proposed fill tested and confirmed to meet the minimum requirements by a soil scientist registered in the State of Missouri as an onsite soil evaluator.

4. Sheet C-107

a. ADD a 1" combination air/vac release valve and vault right after the North Lift Station and Valve Vault No. 1. Reference Detail 3/C-502. Contractor to install at the high point of the force main, Coordinate with the Owner on the proposed location.

5. Sheet C-108

- a. REVISE Equipment and Item List 10 as follows:
 - 10. 2" PR200 (SDR21) PVC Force Main

6. Sheet C-111

- a. REVISE General Note 4 as follows:
 - 4. The existing park bench at the playground shall be relocated to the relocated playground site.

7. Sheet D-301

a. REVISE the Septic Tank 1 - 10,000 gallon WSE to 851.41 ft.

8. Sheet D-502

- a. REVISE Detail 1 Typical Lateral Section lateral length from 63'-0" to 64'-0".
- b. REVISE Detail 1 Typical Lateral Section total lateral length from centerline of manifold supply line to centerline of meter pit from 70'-0" to 71'-0".
- c. REVISE Detail 1 Typical Lateral Section from 1-1/2" to 2" SCH 40 PVC Manifold Supply Line.
- d. REVISE Detail 2 Supply & Manifold Trench Detail from 1-1/2" to 2" SCH 40 PVC Manifold Supply Line.
