- 3. Section 263613 NON-AUTOMATIC TRANSFER SWITCHES
  - a. Paragraph 2.2 A: CHANGE "240 volts, 1-phase, 60 hertz, 3 pole, 3 wire" TO "240 volts, 1-phase, 60 hertz, 3 pole, 3 wire with the third pole to be used for switching the system neutral".
- 4. Section 263623 AUTOMATIC TRANSFER SWITCHES
  - a. Paragraph 2.2 A: CHANGE "240 volts, 1-phase, 60 hertz, 3 pole, 3 wire" TO "240 volts, 1-phase, 60 hertz, 3 pole, 3 wire with the third pole having an overlapping "make before break" contact for switching the system neutral".

If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.

The Contractor shall pay not less than the prevailing hourly rate of wages for work of a similar character in the locality in which the work is performed, as determined by the Missouri Department of Labor and Industrial Relations. Bidders are to adhere to Prevailing Wage Hourly Rate of Wages, and the Department of Labor and Industrial Relations can be contacted to determine the applicable wage rate for the work on this project.
