Bidders are hereby informed that the construction Plans and/or Specifications are modified as follows:

SPECIFICATION CHANGES:

1. Section 323100 – Fencing and Gates
 - a. REVISE Paragraph 2.2-A as follows:
 - A. Barbed wire shall be galvanized; zinc-coated meeting ASTM A121 requirement, Class 2, or aluminum coated meeting ASTM A585 requirements, four strand 12-1/5 gage steel wire with 4 point barbs at 5-inch centers.
 - b. REVISE Paragraph 3.3-A as follows:
 - A. New fence shall be installed to conform to the limits, alignment and finish grade indicated on the Plans. The fence shall consist of four barbed wires with the top wire having an initial wire located 8" above the ground with the remaining wire evenly spaced above grade to at least 4 feet.

If a bidder is unable to meet a participation goal, a Good Faith Effort Determination Form must be completed. Failure to complete this process will result in rejection of the bid.**
