The contractors will provide services on an as needed, if needed basis. A Project Assessment Quotation will need to be utilized and sent to all vendors to request and evaluate their response for award.

The current contract period is June 19, 2021 through June 18, 2022. This is the 2nd and final renewal period. The final expiration date is June 18, 2022.

Current contract period is April 1, 2021 through March 31, 2022 with two (2) renewal options still available. Potential final expiration is March 31, 2024.

Is your governmental entity's website for your bid postings included in the State of Missouri, Division of Purchasing's Bid Locator Tool's search functionality so that more vendors can find your bid opportunities?

The MissouriBUYS Bid Locator Tool is a search engine that crawls Missouri's public sector websites to help vendors and others locate government bid solicitations in Missouri including local, federal and political subdivision bids. Being able to locate public bid opportunities on a single website without having to search multiple sites saves time for vendors and others, and it can mean more visibility for entity bids. Buyers from local government agencies can also view other agencies' solicitations and specifications which can be useful in preparing procurements.

Numerous search fields and filters can be used to locate bid opportunities for all levels of government in Missouri. You can also set up 'Alerts', 'Save' searches and 'Share' bid opportunities with others. Once a bid of interest is selected, the user can click on the 'View Official Site' button and be redirected to the governmental entity's bid page for additional bid details.

The MissouriBUYS Bid Locator Tool is powered by InstantMarkets and is part of the state's eProcurement solution. There is no charge to vendors or Missouri government entities for the

tool. The tool can be accessed by going to https://missouribuys.mo.gov/business-opportunities or by clicking on the Bid Locator Tool button on the MissouriBUYS Bid Board at https://missouribuys.mo.gov/bidboard.

Explore Missouri Government Bid Opportunities Using Bid Locator Tool

The MissouriBUYS Bid Locator Tool, powered by the InstantMarkets application, is a consolidated search page that can be used to **LOCATE** Missouri government (i.e. local, state, federal) and political subdivision bid solicitations throughout Missouri. The Bid Locator Tool is a search engine that crawls Missouri's public sector websites helping vendors find additional public bid opportunities without having to search multiple sites saving valuable time.

The black "FILTERS" button (bottom right) allows users to conduct a search by keyword, locations, timeframes, and many others. Users can select the bid that interests them and be redirected to the governmental entity's official bid site for all the remaining details. The black "HELP" button (bottom right) provides **step-by-step instructions** on how to use the Bic Locator Tool to search for relevant bid opportunities.
