

Single Feasible Source Purchase

Title: Small Rural Hospital Improvement Program

Description: To help small rural hospitals continue to make funds available for costs related to the implementation of Prospective Payment Systems (PPS), such as updating chargemasters or providing training in billing and coding, and costs related to delivery system changes outlined in the Patient Protection and Affordable Care Act, including value-based purchasing (VBP), accountable care organizations (ACO), and payment bundling.

The forty-five (45) small rural hospitals identified below are considered to be a single feasible source because they are identified in the Notice of Grant Award as eligible recipients.
